As at 28 February 2009 the convertible notes with amount of US\$20,000,000 have been converted into 258,333,333 ordinary shares of the Company according to the terms and conditions of the Subscription Agreement dated 30 May 2006 (the "Subscription Agreement"). As a result, remaining 264,609,814 new shares of the Company (approximately US\$17,072,000) which may be issued pursuant to the Subscription Agreement. The remaining balance will be settled by cash pursuant to the Subscription Agreement.
